Job Summary:

Perform installation, repair, replacement, and maintenance of the gas, water, and sewer facilities by skillfully operating a variety of construction and heavy equipment.

Duties and Responsibilities:

- Install, repair, and/or replace service lines, main lines, and meters for gas, water, and sewer facilities.
- Assist with the maintenance of water and sewer lift stations.
- Assist with the maintenance of gas regulator stations.
- Operate hand tools and construction equipment such as jackhammers, pumps, air compressors, etc.
- Operate heavy equipment including backhoe, track hoe, and ditch witch, etc.
- Perform maintenance and repair on assigned equipment.
- Respond to customer complaints regarding gas, water, and sewer leaks.
- Assist with gas, water, and sewer surveys.
- Drive company vehicles.
- Assist in emergency situations.
- Subject to overtime, emergency call-out, and stand-by.
- Complete other duties as assigned.

Required Skills and/or Abilities:

- Acknowledge and adhere to all of LUS' policies and procedures.
- Perform duties safely without endangering self, others, and the public.
- Ability to read, write, understand, and follow instructions and job-related materials.
- Ability to use mathematical skills to be able to add, subtract, multiply, and divide all units of measure.
- Ability to skillfully use hand tools or machines needed on the job: jackhammers, pumps, air compressors, etc.
- Ability to skillfully use heavy equipment needed on the job: backhoe, track hoe, ditch witch, etc.
- Take responsibility for your own actions and treat others with respect.
- Attend work regularly and on time.
- Ability to work scheduled and non-scheduled overtime.
- Attend safety training and other meetings as scheduled.
- Ability to follow all safety guidelines required by OSHA.
- Ability to work outside and be exposed to noisy places, fumes, chemicals, toxic substances, and machinery.
- Ability to be exposed to all weather conditions including cold, hot, rainy, and windy.

Physical Requirements:

- Ability to regularly lift and/or move up to 75 pounds.
- Ability to use eyes, hands, and fingers to operate equipment.
- Ability to walk and stand for 8 hours a day.
- Ability to talk, see, hear, reach, handle, and feel.
- Ability to stoop, bend, climb, crawl, and twist.

Education, Experience, and Qualifications:

- Valid State of Tennessee Class A Commercial Driver's Permit required within six (6) months of hire and License required within two (2) years of hire.
- Minimum of five (5) years of experience operating heavy equipment required.
- Minimum of three (3) years of previous experience in gas, water, or sewer utility experience preferred.
- State of Tennessee Grade II Distribution System Operator Certification or ability to obtain within two years required.
- State of Tennessee Grade II Wastewater Collection System Operator Certificate or ability to obtain within two years required.
- State of Tennessee Gas Operator Qualification (OQ) or ability to obtain within two years required.
- Certification of Completion of Flagger Training Course or ability to obtain within two years required.
